PM Internship Scheme

Scheme Objective:-

Launched by the Ministry of Corporate Affairs (MCA) in 2024-25, with the aim of providing total 1.25 lakh internship opportunities to youth, in top 2000 Companies of India, based on CSR expenditure of last 3 years.

Through this Scheme, youth will gain exposure to real-life business environment, across varied professions and employment opportunities.

Monthly assistance & duration: Rs. 9000/- (90% MCA share through DBT & 10% Company share through CSR/ own fund). Additional one time grant of Rs. 6000/- (in two tranches within 15 days and on completion of 3 months) Duration is either **6 months** or **9 months**, based on sector and company requirement.

- Partner companies
- Industry Associations
- State Government

Insurance Coverage:

“Pradhan Mantri Jeevan Jyoti Bima Yojana” (PMJJBY) coverage for interns by Govt.

- (i) Indian citizens aged **between 18 to 25 years** (as on application date), not in full-time employment.
- (ii) Education: 10th/12th, ITI, Diploma, UG/PG (e.g. B.A./B.Sc/B.Com/BCA/BBA/B.E./B.Tech /M.A./M.Sc/ M.Com/MCA/M.Tech)
